# FIRE MUSTER VENDOR APPLICATION

## GENERAL REGULATIONS

- Event Date: **Saturday Sept 28, 2024**. Rain date Sunday Sept 29, 2024
- Setup 8 AM - 10 AM. Open to public 10 AM to 5 PM
- The NCFCA agrees to provide a commercial space for the vendor indicated during the Muster Event.
- Vendor agrees to accept the **Assigned** space with no guarantee of provision for electricity or Wi-Fi.
- The NCFCA or the NC Fire Museum will accept no deliveries of displays or merchandise.
- The NCFCA has sole discretion to determine all aspects of the event, including, but not limited to other vendors, timing and location.
- Vendors must be **ARRIVE & SETUP AT LEAST 1.5 Hr in ADVANCE** to the event Start. Affixing anything to the facility structure is prohibited.
- All booths must remain intact until the close of the event and no exhibit additions or removals are allowed during the event. Vendors and attendees are required to **LEAVE within 1 Hour After** it ends unless prior arrangements are made with the NCFCA or the Fire Museum.

## VENDOR SPACE REGULATIONS

- Vendor must **Provide own tables, chairs and/or tents as needed**.
- Vendors with **Tents/ Canopies are required to secure them with weights and obtain Liability Insurance**.
- The sale of guns or weapons of any kind is strictly prohibited.
- Devices that project sound may be played only at a low level that does not interfere with other sponsors in any way. Loud music and objectionable lighting effects are prohibited.
- All aisles must be left open and clear.
- All vendors must properly dispose of all unwanted merchandise at the end of the event.
- All booths must be staffed during event hours.
- Sharing or subletting space is strictly prohibited.
- Any vendor booth that interferes with other exhibits, extends beyond the designated space, or is deemed objectionable by the NCFCA must be immediately modified or removed by the vendor.

## FOOD VENDORS, ADDITIONAL REQUIREMENTS

- Food vendors must agree to and will comply with all the stipulations above.
- No alcoholic beverages are allowed.
- All food vendors must be in **Full compliance with all Fire, Safety, Food and Health Regulations**, including valid insurance, inspection certificates and licenses as required by local, city, state and federal ordinances.

## LEGAL DISCLOSURES

- The NCFCA reserves the sole right to promulgate, interpret, amend and enforce all rules and regulations, and to alter the event plan and schedule in the best interest of the participants, exhibition and the exhibitors.
- The **NCFCA & the NC Fire Museum assume no responsibility** for the exhibit area. The NCFCA does not maintain liability insurance. It is the sole responsibility of the vendor to obtain such insurance as needed.
- Vendor is solely responsible and liable for losses, damages, and claims arising out of vendor's activities and shall indemnify, defend and hold harmless the NCFCA, The NC Fire Museum, their respective officers, directors, servants, agents and employees from any and all such losses, damages, and claims.
- The Vendor is responsible for safeguarding their own property at all times. NCFCA does not guarantee the prevention of occurrences which may result in loss or damage.
- The Vendor may neither state nor imply endorsement by the NCFCA - except when provided specific written permission with prior approval.
- The Vendor is solely responsible for compliance with F. X. Pendl Museum, Local, City, and Federal ordinances and regulations.
- Gross violation of the agreement stipulations may result in ejection from the event and prohibited access to future events.
